

AGREEMENT
between the Government of the Slovak Republic
and the Government of the People's Republic of China
on the extension of the consular district of the Honorary Consulate
of the Slovak Republic in the Hong Kong Special Administrative Region

The Embassy of the Slovak Republic in Beijing presents its compliments to the Ministry of Foreign Affairs of the People's Republic of China, and on behalf of the Government of the Slovak Republic, confirming the common desire to develop the friendly relations between both countries, has the honour to propose the conclusion of The Agreement between the Government of the Slovak Republic and the Government of the People's Republic of China on the extension of the consular district of the Honorary Consulate of the Slovak Republic in the Hong Kong Special Administrative Region as follows:

The Government of the People's Republic of China gives its consent to the Slovak Republic to extend the consular district of the Honorary Consulate in the Hong Kong Special Administrative Region to include the Macao Special Administrative Region.

If the above content is confirmed by the Ministry of Foreign Affairs of the People's Republic of China on

behalf of the Government of the People's Republic of China, this note, together with the reply note of the Ministry of Foreign Affairs of the People's Republic of China shall constitute The Agreement between the Government of the Slovak Republic and the Government of the People's Republic of China on the extension of the consular district of the Honorary Consulate of the Slovak Republic in the Hong Kong Special Administrative Region, which shall enter into force on the 30th day upon the reply note of the Ministry of Foreign Affairs of the People's Republic of China.

The Embassy of the Slovak Republic avails itself of this opportunity to renew to the Ministry of Foreign Affairs of the People's Republic of China the assurances of its highest consideration
